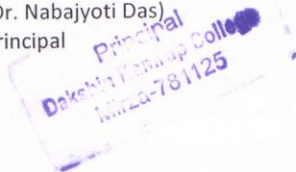

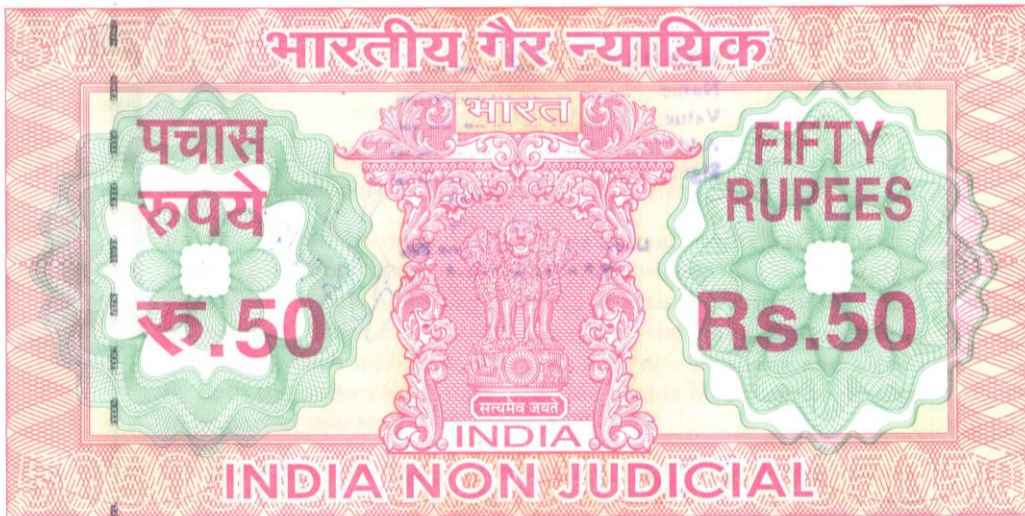

MEMORANDUM OF UNDERSTANDING

- v) The MoU is not intended to create any legal relation of employer-employee or of principal and agent relationship amongst the parties.
- vi) This MoU shall remain valid for a period of five years from the date of its signing, and can be extended on mutual terms and conditions.
- vii) Both the parties shall assist each other in undertaking their respective academic activities through making faculty and other support available for the purpose.
- viii) Both the parties shall undertake joint research, study visits, content development, development of training aids etc. in the areas as may be agreed upon and as may be beneficial for their respective target groups and/or joint initiatives.
- ix) Both the parties shall suitably advise their respective affiliates/associates to undertake activities/measures as may be useful for promotion of activities of both the parties and/or joint activities.
- x) Both the parties shall regularly share the relevant information and make their respective facilities available to each other for due performance of the agreed activities.
- xi) Both the parties shall also identify the capsule/short term entrepreneurship/ skill development programme(s) which may be organized under the joint banner of both the parties.
- xii) Both the parties shall sponsor its Faculty/Support Staff to the development courses etc. being run by the other party.

- xiii) Both the parties shall share the information which may come in its knowledge/possession as may be useful either for the joint activities or activities of the either party.
- xiv) Both the parties shall undertake all the feasible measures for promoting the activities of the other party.
- xv) Both the parties shall hold regular meetings for identifying the areas of specific joint action/collaboration and reviewing the progress of the on-going activities.
- xvi) The financial and other details of the activities shall be as may be mutually decided.
- xvii) IIE, having expertise and experience in the field of entrepreneurship development, skill development, research and consultancy, cluster development, monitoring, evaluation and impact assessment, can extend its services on mutually agreed terms and conditions.
